It is current QTC Policy that Overseas Students are charged at the same rate as Domestic students.

**The spouse of a current QTC Full Time student studying towards a three or four year degree** may apply to study one year of a Diploma/Degree full time (or part time equivalent) up to a maximum of 32cp at the cost of the ACT Admin Fee (\$218 per unit in 2018), normally for **as long as the primary student in the couple remains enrolled for four or more units in the current semester** and in a three or four year course of study. This applies to the spouse of a full-time overseas 3-year degree student if allowable under the individual's visa conditions. For **spouses of students who are studying the shorter qualifications**, (i.e, the 1 year Diplomas and Graduate Diploma) the spouse discount shall be 50% of the total fees payable, for up to 32cp (or one year full time) and for as long as the primary student in the couple remains enrolled full time in a course of study at QTC. *Spouse discounts are not available for Study Tour.*

**Current QTC Full Time Students** may audit **one unit per semester**, without having to pay the audit fee.

# **MA Degrees:** Students living more than 200km from Brisbane, and within Qld, NT or Northern NSW are eligible for a reduction of \$250 off their total fees to offset travel costs.

@ **MTh/PhD:** This is an Annual Fee. Full-time Master of Theology or PhD students enrol in 32cp/year. Part-time students enrol in 16cp/year and pay half the 32cp fee.

\* A discount applies to domestic students who are QTC graduates or full time ministry workers serving with Qld, NT, or Northern NSW. Please contact our Registrar for details.

<sup>^</sup> Note the Study Tour fee is the maximum amount you can put on FEE HELP. It excludes the cost of accommodation, transport, insurance, beverages and meals. Please refer to the Study Tour Handout. *Spouse discount not available.*

**Fee for Withdrawing from a normal Semester Unit after Admin Date is \$100 per unit (form to be filled out from QTC office). Compassionate withdrawal will be considered at the Principal's discretion.** Fee from withdrawing from an MA Unit after attending the classes for the unit is \$350 per unit. **No Refunds are available after the Census Date.**
