Information about this unit

Unit description

For most students of the Old Testament the book of Ezekiel is a riddle. A primary goal of this course is to unlock the keys to this mysterious book through a firsthand look at the biblical text and to recognize its significance for ministry in the 21st century.

Learning outcomes

1. To become familiar with the nature of the Israelite prophetic institution within the context of its ancient Near Eastern religious and cultural environment, including the literary nature of prophecy, especially the influence of extra-Israelite forms of expression and ideology.
2. To gain a general familiarity with the content of the book of Ezekiel, at a suitable level for those who have already completed a theological qualification and who are serving in pastoral ministry and related roles.
3. To gain an appreciation for the Israelite prophets' sensitivity to the sociological context of their ministry and the variety of rhetorical methods they employed to seek to change the dispositions and actions of their audiences.
4. To gain an understanding of the significance of Ezekiel's message for the audience of his day and the influence of this prophet on later Israelite thought.
5. To comprehend the permanent relevance of the teachings of Ezekiel and to examine ways of integrating these into one's own theology and applying them to life.
6. To discover concepts in Ezekiel's writings that will assist one in developing a valid prophetic theology of ministry for today.
7. To be inspired and challenged by the example of Ezekiel, and to be strengthened in one's confidence in the authority of the biblical message.

This Unit & the MA Course

This unit is taught at the MA (700) level, and if successfully completed, is worth 4 or 6 credit points towards the Australian College of Theology Master of Arts (Theology), Master of Arts (Ministry), and Master of Arts (Christian Studies) courses.

QTC offers a regular series of MA units which provide the opportunity to complete the MA (Theology), as well as selected units towards the MA (Ministry). It may be possible for students to apply the credit gained from completing this unit to MA-level qualifications beyond the Australian College of Theology (ACT). Students should contact the relevant non-ACT provider for details.

Pre-requisites and Co-requisites

Students need normally to have previously completed the equivalent of at least three years of full-time theological study, such as a BTh, MDiv, BD, BMin, MMin, or equivalent, from the Australian College of Theology (ACT), Moore Theological College, or another recognized provider. Students who are enrolled in an ACT MDiv and have completed 64 credit points may enrol in this unit with the permission of QTC.

The unit is delivered as an ACT MA-level course, coded **OT789-4i** and **OT789-6i**.

ELIGIBILITY FOR EACH STRAND OF THE UNIT

Students who have an ACT MDiv or ACT BTh (Hons) (or equivalent AQF Level 8 or 9 qualification) take OT789-4i - worth 4 credit points towards a 32 credit point MA.

Students who have an ACT BTh (or equivalent AQF Level 7 qualification) take OT789-6i – worth 6 credit points towards a 48 credit point MA.

If you are already enrolled for an MA under the previous ACT rules, then your course will need to be converted to one of these awards. Please contact us beforehand about this.

The teaching will be the same for both units, but there is more pre-reading and there are longer assessment pieces for OT789-6i than for OT789-4i. Further details are listed in this unit outline.

How this unit is organized & what we expect of you

Students will be expected to attend all lectures, with the lectures being held in Intensive mode: **Monday 26 August – Friday 30 August 2019**.

The unit will be taught through 25 teaching hours, with three teaching periods per day for each day of the intensive week. Each teaching day will commence at **9:30am** and conclude at **3.30pm**. Please arrive in good time each day for the commencement of lectures.

To complete the unit, students need to attend the Intensive classes with Professor Daniel Block, complete the set pre-reading, and submit all three assignments at a satisfactory level. The due dates for submission of the assessment items are listed in this unit outline. Full details regarding study at QTC and on matters such as using the QTC Library and applying for extensions on assessment due dates can be found in the QTC Student Handbook, available on the QTC website.

Please note that **the first piece of assessment is based on the pre-reading**, and is due for submission on the Friday evening immediately prior to the Intensive week, **Friday 23 August** (at 11:55pm).

PRE-READING FOR STUDENTS OF OT789-4i:

For OT789-4i, the required pre-reading is **300** pages:

1. Read aloud the entire book of Ezekiel from a modern translation. Note: While for detailed study a version based on "formal equivalence theory" (e.g., NAS, ESV) is preferable, for this exercise a version that is based on "dynamic equivalence theory" (e.g., NLT, NIV, NRSV) is more helpful.
2. Read the following collections of essays on the book of Ezekiel:
 - a: Block, Daniel I. *By the River Chebar: Historical, Literary, and Theological Studies in the Book of Ezekiel*. Eugene, OR: Cascade, 2013. (please read all nine essays in the volume)
 - b: Block, Daniel I. *Beyond the River Chebar: Studies in Kingship and Eschatology in the Book of Ezekiel*. Eugene, OR: Cascade, 2013. (please read the first chapter and one other chapter of your choice from this volume).

Total of the above readings: approximately 300 pages (depending on Bible version used).

PRE-READING FOR STUDENTS OF OT789-6i:

For OT789-6i, the required pre-reading is **400** pages:

1. Read aloud the entire book of Ezekiel from a modern translation. Note: While for detailed study a version based on "formal equivalence theory" (e.g., NAS, ESV) is preferable, for this exercise a version that is based on "dynamic equivalence theory" (e.g., NLT, NIV, NRSV) is more helpful.
2. Read the following collections of essays on the book of Ezekiel:
 - a: Block, Daniel I. *By the River Chebar: Historical, Literary, and Theological Studies in the Book of Ezekiel*. Eugene, OR: Cascade, 2013. (please read all nine essays in the volume)
 - b: Block, Daniel I. *Beyond the River Chebar: Studies in Kingship and Eschatology in the Book of Ezekiel*. Eugene, OR: Cascade, 2013. (please read the first chapter and five other chapters of your choice from this volume).

Total of the above readings: approximately 400 pages (depending on Bible version used).

OT789-4i (4 Credit Point Unit) Assessments

Guide to Assessments

What are we looking for?

General Remarks

All students are expected to avail themselves of the guidelines for written assignments provided in the ACT Handbook (consult the table of contents) and in the QTC Student Handbook.

All written work for this course for this course should conform to the guidelines of the *SBL Handbook of Style* (with the exception of Australian spelling conventions).

Any Hebrew and Greek cited must be typed in a Unicode font; SBL BibLit is commended as one font covering Hebrew, Greek, and Roman Unicode ranges, but is not required. It is freely available from the SBL website: http://sbl-site.org/educational/BiblicalFonts_SBLBibLit.aspx

The appended bibliography is offered as a starting point for research in completing assessments for this course; students are expected to engage the works listed there, but not limit themselves to these resources.

Do note carefully the **number of words required** for each assessment item, depending on whether you are enrolled for OT789-4i or OT789-6i.

In order to pass this unit, you must gain a mark of at least 50% for the unit as a whole. All assignments should be submitted via the QTC Moodle website: <http://www.qtc.edu.au/moodle/>. Students will be provided with a Moodle account and details of how to access and use this account before the Intensive commences.

Expository Sermon

This assessment engages the last two seminar objectives listed above. Students are expected to show a thorough and detailed engagement of the details of the text chosen for exposition, with strong support from good secondary literature (especially on disputed points of interpretation). While the focus of this assignment is on exegesis and interpretation, as a sermon it must drive home the theological point of the selected passage for a contemporary audience.

Essay

The essays are intended to provide hands on experience in fulfillment of the objectives for the seminar listed above. By grappling with the assigned topics, students have opportunity to explore theological themes and exegetical issues raised by the Book of Ezekiel, and develop their understanding of the themes in conversation with the work of earlier interpreters. Students are expected to show thorough knowledge of the primary literature and engage deeply and sympathetically with a broad range of secondary literature that bears on their chosen topic, including both more advanced commentaries and relevant monographs.
